- The acquisition amount is within 200,000,000,000 KRW, and it can be changed according to market price fluctuations.
- The number of shares to be acquired, number of shares held and shareholding ratio after acquisition are based on the closing price(Amorepacific corp. common share, 150,000 KRW) of 8th Oct. 2019, and can be changed according to market price fluctuations.
- 'Scheduled Acquisition Date' is the end date of acquisition date of acquisition period (12th Dec. 2019~ 11th Dec. 2020). The acquisition will be started from the day after end date of public offerings subscription (11th Dec. 2019) by decision on rights issue, and the end date of subscription can be changed according to discussion with related authorities/organizations. The acquisition can be completed at any time during the period.
